

# IAEM Certification for Emergency Managers



## Why Earn A Certification?

**Certification Fee:** The current fees are listed on the IAEM website at [www.iaem.org/get-certified](http://www.iaem.org/get-certified). The certification fee entitles applicants to:

1. **Sit for the exam twice** (if the applicant does not pass the exam on the first attempt).
2. **Certification application reviewed twice** (if the application is not approved the first time).

### The Steps:

1. **Complete** the Certification Enrollment form on the IAEM website: [www.iaem.org/get-certified/Certification-Enrollment](http://www.iaem.org/get-certified/Certification-Enrollment)
2. **Pay** the certification fee.
3. **Complete** the below two steps within one year of each other (order doesn't matter):
  - a. Pass a multiple choice exam
  - b. Obtain approval of your certification application.
4. **Recertification is required** every five years by documenting continuing education and contributions to the profession.

# Levels of Certification



There are two types of certifications offered: the **Associate Emergency Manager (AEM®)** and the **Certified Emergency Manager (CEM®)**

## AEM® Requirements

### *Training*

Submissions must be within the last 10 years. 200 contact hours are required; 100 each in emergency management and general management.

### *Letters of Reference*

One signed letter from applicant's current supervisor, plus contact information for two additional references, with the option to provide two additional signed letters of reference if applicant feels it would be helpful to his/her application.

### *Multiple-Choice Examination*

Applicants must pass a multiple-choice examination. The exam is taken electronically and administered by an approved proctor. The examination includes questions that are considered to be universal core content for emergency management regardless of location. Additional content is included based on the applicant's geographic location.

## CEM® Requirements

**Complete all requirements listed below, including AEM® requirements:**

### *Emergency Management Experience*

Three years by date of application submission. Comprehensive experience must include participation in a full-scale exercise, two functional exercises, actual disaster, or a major public event such as a major sporting event, state visit, or special event, and must encompass multiple areas of emergency management (mitigation, preparedness, prevention, response, and recovery).

### *Contributions to the Profession*

Submissions must be within the last 10 years. Six separate contributions are required in areas such as professional membership, conference attendance, service role, leadership role, special assignment, speaking, teaching, course development, publication, audio-visual and interactive products, awards or special recognition, professional certification related to emergency management, or legislative contact. ### *Education*

- **U.S. applicants**—Any four-year baccalaureate degree.
- **Europe & Oceania applicants**—Any baccalaureate degree.
- **Canadian applicants**—Any three or four-year baccalaureate degree or program. Or, any post-graduate degree in EM or related field.
- **Asian, Latin American & International applicants**—Any baccalaureate degree or equivalent thereof, or additional experience may be substituted at two years of full time Emergency Management employment per year of college/university.
